Futsal is FIFA's official indoor soccer game. It is essentially a scaled-down version of outdoor soccer played indoors. Futsal is a small-sided game (5v5 or 4v4) played on a smaller field (basketball court sized) with a smaller (size 3-4) ball. Futsal is played with touchline boundaries.

Because the sport is a great skill developer, demanding quick reflexes, fast thinking, pinpoint passing, and lots of touches on the ball, it is an exciting game for the players. These properties are specifically designed to build confidence on the ball and develop better skill and technique.

You can either sign up as an individual player for \$120.00 and we will assign you to a team or you can put together a team for \$960.00 (Max 8 players on a team). We will have two divisions based on age and ability. There is limited space so don't delay in signing up!

This program is run by Coach Dane (Danny) and the NS Premier Staff. Game schedules will come out a week prior to the first game.
